And compassion for those who need me...

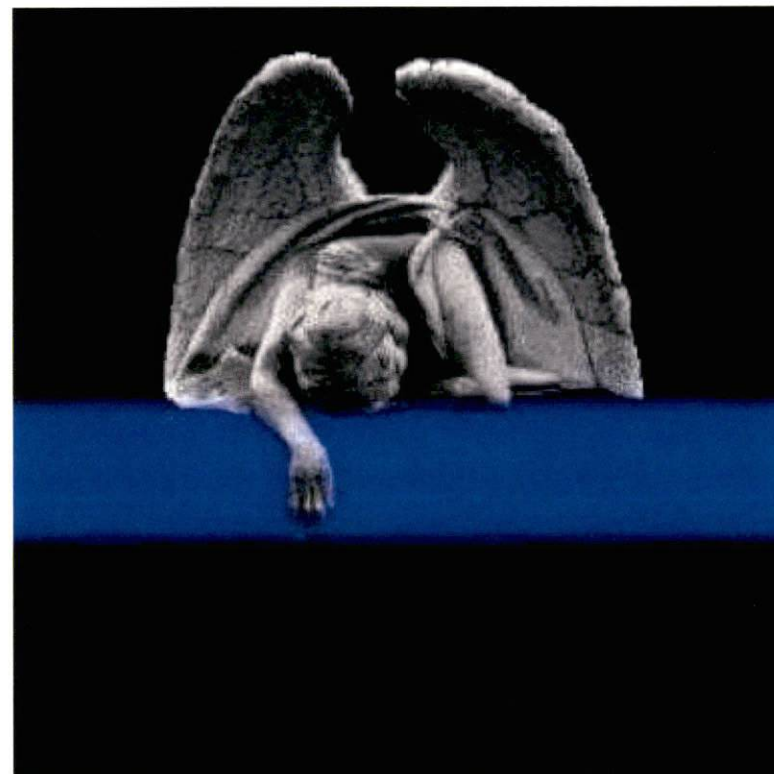
