Discussion: Sister Vanderpool asked about the Bingo Account and "the refund from the taxes". She was informed by Treasurer Shick and President Canterbury that the Quarterly statement was mailed today and we received our last \$3,000 Quarterly check two (2) months ago so we should be receiving our next one within a month or so. She asked if we made any deposits into the Fundraising account and she was informed by Treasurer Shick that we had not due to the Fundraising Company being asked to hold off on contacting anybody since repeatedly contacting Angelo's.

Second Vice President – Brother Shick: Nothing significant to report this month.

Recording Secretary – Sister Pike: Normal duties of the station

Sergeant In Arms – Brother Wells: Checking on a couple of members from the lodge regarding their welfare. Brother George Freese went overseas to Italy and fell and broke his leg. As of today, they are saying he should be released between this coming Saturday and Monday to be sent back home via MediVac and admitted here in the states. Spoke with Brother Bob Budner and he stated that he had gone

to the hospital to have his Gallbladder worked on and stayed in the hospital with that since it was highly infected.

**Discussion:** Sister Dean inquired why we were still attempting to use and work with GoDaddy. Sister Vanderpool reported that when we entered into the contract with GoDaddy, it was a multi-year contract that was paid up front. The E-mail portion was a three (3) year contract and we are in year two (2) of it. The Web Hosting and the Security portions were five (5) years each. The IT Committee is working on proposals for other potential solutions. Sister Dean stated that even though Sister Vanderpool states that we are currently under contract with them we should be able to get out of it since they are obviously not provided the services that were promised under the contract. Sister Vanderpool stated that we could leave GoDaddy but we would not get our money back. Both Sister Dean and President Canterbury informed Sister Vanderpool that if GoDaddy is not holding up their end of the contract, under the law, it is considered *Breach of Contract* and we would be entitled our money back. Brother Canterbury stated that he would consult a Civil Attorney about the matter. Sister Vanderpool brought up that GoDaddy may fall under California Laws for arbitration. Sister Vanderpool stated that she will get the GoDaddy contract to President Canterbury and will get a quote to the E-Board for Jason to take over the website domain. Brother Shick stated that he has established, developed, and maintains the webpage and e-mail client for his motorcycle rodeo. Sister Vanderpool stated that she will bring the proposal to the next meeting (October meeting). Sister Pike brought to the attention of the IT Committee the unprofessional look of our website that Jason was supposed to be working on and completing for quite some time.

**New Business:**

From the Board: Christmas Party Committee needs to be established as it is coming up soon.

Sister Vanderpool is speaking with Olive Garden regarding their ability to cater our party again this year. Each pasta station is \$135 and feed 10-12 people. If we have 50 people attend it will be 5 stations at \$135 so \$675 total which includes breadsticks and desert. We can have fewer pasta stations and add some family size entrees like chicken parmesan or lasagna. A 6 person serving is \$46.99 and a 12 person serving is \$56.99 for lasagna. 4 Pasta stations and 2 large lasagnas would be \$596.99. We can set it up between 17:30 and 18:00 so that we can have hot water stations set up when the food gets there. The appetizer station was about \$50 last year.

Brother Wells would like to get a food quote from Angelo's. Sister Vanderpool says she was just there at Angelo's and the food was not good, it was under cooked and he did not have enough staff to give her a private room so she was not happy with Angelo's at all so she does not feel that we should go with them or that he could do it. Brother Wells said he will get a quote from them for 75 people because Angelo has expressed a desire to help us out and give us a quote to cater it.

**SC FOP LODGE 12 IT COMMITTEE REPORT**  
**October, 2025**

This month the IT Committee continued its efforts to assure that the GoDaddy email subscriber list is complete, accurate, and functioning as it is supposed to.

First, thank you to Jim Tolman for forwarding the list of new Members from the September Meeting to us so quickly. We were able to input the information within days of the Meeting.

A post update check of the subscriber list disclosed that a new entry was moved to the "suppressed" list, marked as "manually suppressed". This would prevent that email from receiving emails. That address had been added in the regular established manner, marked "double opted in" which indicates that it has been confirmed as an email address that is to receive all emails.

I returned to the menu to add emails to the list and re-entered all of the information, received the standard popup indicating that the email had been successfully added. I once again checked the subscriber list and once again that email was coded as "manually suppressed".

After multiple unsuccessful attempts to add the email to the subscriber list, an email was sent to GoDaddy requesting information as to the criteria for adding email addresses to the suppressed list, who controls the process, and how it occurs. There has been no response from GoDaddy. This is a continuation of the issues we've been trying, without success, to correct and eliminate for months.

Now I'll ask IT Member Don Nadler to report on his work on the GoDaddy/email list issues.

**SC FOP LODGE 12 IT COMMITTEE REPORT**  
**October, 2025**

As Stepahanie has stated, the problems with GoDaddy persist, and the more we look at it the worse it seems.

As I mentioned last month, it appears that GoDaddy's list of people they sent us of who are not receiving our emails has several components, such as soft bounce and hard bounce, which I believe correlates to another designation when we view the list on line of those who are "suppressed", or not on our active email list.

I have been going over their "suppressed" list and have found designations of 'email undeliverable' and 'email permanently undeliverable.' Cross checking those that are listed as either designation, I found that any of the email addresses were not associated with anyone on the roster list that we received in July nor are they new members.

Also found in the suppressed list were several names that were supposedly not able to receive emails, but they showed as having opened the last meeting notification email. Since they were on the members list and had received and opened the latest email, I took the liberty of taking them off of the suppressed list.

The GoDaddy list had many emails associated with a last name only, so I am in the process of adding first names to those using the information on the Roster list we have.

As Stepanie mentioned, attempting to do certain functions will show a pop up which states it was successfully done, but when double checking, nothing has changed. I ran into the same issue while trying to delete names that I could be 100% certain were no longer to be on the list. I tried to delete information 3 days in a row, each day being told it was successfully deleted, only to find it still there the next day.

We are still waiting to be contacted by GoDaddy with explanations on our questions we have submitted, as well as waiting to hear from other lodges that use GoDaddy successfully that were to be referred to us by President Canterbury after the last meeting.
