Discussion: Same discussion as the last countless number of months. Sister Vanderpool discussed again that we had numerous issues with “jin jally”(sp) in the past when we used them and were unable to convert a lot of things and we are having lots of issues with GoDaddy and finding new issues all the time. E-mails are getting kicked back repeatedly and kicked back. The sooner we get away from GoDaddy the better we will be because they are causing nothing but frustration to everyone. IT Committee is still working with Jason to try to get our website up and running and working properly.

Brother Gavin stated that he is holding off on sending the E-Board and Brother President Canterbury Jason's Draft Contract to take over the website because when he talked to Brother Canterbury he was going to send it to him and go over it with him. THE FOLLOWING NOTES WERE DEVELOPED AS A RESULT OF A MEETING OF THE IT COMMITTEE-- STEPHANIE, DON AND ED, AS WELL AS JASON, OUR LODGE WEBMASTER AT CRAVES RESTAURANT, MYRTLE BEACH ON NOV 12, 2025:

Action Items:

- Speaker C - Call KC to discuss website migration
Contact KC to coordinate the transition from GoDaddy and discuss technical requirements and timing.
- Speaker C - Prepare and upload FAQ page
Draft a list of frequently asked questions and answers for both public and members-only sections, and upload to the new website.
- Speaker D - Finalize and send updated master roster
Clean and reconcile the master member list, resolve discrepancies, and send the updated list to Speaker C for website integration.
- Speaker B - Summarize Jason's input and coordinate next steps
Relay outcomes of discussions with Jason to the group via email and help plan the migration process.

Overview:

- Discussion focused on website modernization and data management for The LODGE.
- Consensus to move away from GoDaddy due to technical limitations and poor support for custom features.
- Emphasis on improving member application forms (required fields, digital signatures, data accuracy).
- Plan to implement Mailchimp for professional email campaigns and better deliverability (\$45/month for up to 2,500 subscribers).
- Need for a master member roster and improved data hygiene (emails, phone numbers, addresses).
- Action items include preparing an FAQ page, updating forms, and coordinating with key stakeholders for migration.

Website Platform Issues and Migration Planning:

- Website access issues persist with GoDaddy.
- Request to change yellow button text to 'Join our lodge, click here'.
- Application form should include a field for Facebook name for member verification.
- Form should provide clear instructions for general and legal defense membership.
- GoDaddy blocks custom code; migration from GoDaddy discussed.

Member Application Forms and Data Collection Challenges:

- GoDaddy hosting blocks custom code and file editing, limiting website functionality.
- PDF forms and online signature features developed but cannot be implemented due to GoDaddy restrictions.
- Wix and similar platforms do not provide full control or SEO benefits; not recommended for business needs.
- WordPress Bakery is the current website builder; confusion exists about platform usage among members.
- Members must vote on switching from GoDaddy; proposal and contract draft to be sent to decision-makers.

Email Campaigns, Communication, and Mailchimp Adoption:

- Digital application form now requires all key fields; cannot submit incomplete forms.
- Manual account creation required for members without email addresses; email needed for site login.
- GoDaddy domain can be pointed to new host via DNS; propagation typically under 24 hours; annual domain fee approx. \$9.
- Mailchimp recommended for email campaigns; supports audience segmentation, reporting, and up to 6,000 emails/month for 1,000 users; cost approx. \$45/month.
- Meeting minutes and e-board pages updated; documents viewable online without download, following best practices.

Master Roster, Data Hygiene, and Reporting:

- Mailchimp provides high deliverability (85–90%) via domain verification with major email providers.
- Mailchimp used for large campaigns (e.g., 60,000 recipients for spring break events) and tracking engagement.
- GoDaddy email often caught in spam filters; lacks advanced tracking and verification features.
- Recommendation to create a FAQ page to address recurring member questions and reduce email volume.
- Need for a single, accurate master roster to maintain up-to-date member information and ensure compliance.

FAQ, Member Education, and Next Steps:

- Master list and GoDaddy roster compared; discrepancies found between lists (580 vs 640 members).
- Contacted members missing emails/phone numbers; received over 50% response for missing emails.
- Manual and AI-assisted list reconciliation discussed to streamline data management.
- Proposed website upgrades: online dues payment, automated reminders, member FAQ, and AI chatbot for support.
- Postage costs for mailings deemed inefficient; recommendation to shift to digital communication and automate processes.

Further discussion:

- Ability of our Lodge Website to generate donations, and need to discuss this with E-Board, and make sure proper Official forms and approvals are in place.
- Contact GoDaddy to possibly obtain a credit for unused services, and apply all credit to ongoing domain registration renewals which will remain with GoDaddy.
